The Friends of the Countryside is a non-profit making organisation consisting of a network of more than 700 private landowners, rural managers and entrepreneurs based primarily in Europe but with members spread "from the Rockies to the Urals"*.

Since its formation in 1988, this network not only allows private entrepreneurs to advocate rural property rights and the important function of land management, but it also establishes a dialogue between decision-makers, entrepreneurs and rural owners whose aim it is to ensure a countryside that is economically, socially and environmentally sustainable. The basic principle of this network is founded on the belief that **property rights** are the underlying force behind long-term projects, investments and achievements in rural areas.

The organization serves as a network for young rural entrepreneurs who plan to be the landowners and managers of tomorrow. What the members of this network share in common is a passion for topics relating to land ownership, the European countryside, land management and rural entrepreneurship.

Our objectives are:

- To raise awareness among its members about European environmental policies, European rural business opportunities, and estates & historic houses inheritance and management processes
- · To promote educational philanthropy in the countryside
- To represent and channel the YFCS voice at the EU level through the European Landowners Organization
- To provide information and assistance to its members regarding management and legal issues concerning the countryside and rural businesses.


